Action Paintball Park LLC Rules

1. All participants must be at least 8 years of age to play
2. Any participants under the age of 18 must be accompanied by a parent and/or legal guardian.
3. All Paintball Markers must not shoot faster than 280 feet per second and each marker will be checked before each game.
4. All participants must wear approved goggles at all times while on any Paintball field and inside designated shooting ranges.
5. All Paintball Markers must have a barrel sock fixed on the marker until a staff member instructs you to remove it.
6. No alcohol is permitted on the property.
7. Smoking is only permitted in designated smoking areas. No Smoking is permitted outside of these areas.
8. No fighting or personal contact with any other participant is permitted.
9. All participants must follow all directions from staff members at all times.
10. No firing of Paintball Markers is allowed in the parking lot or staging area. Paintball Markers may only be fired during live games and at designated shooting ranges.
11. All participants must wear full pants, long sleeve shirts, and shoes at all times. *Shorts are not allowed!*
12. All games must be supervised by a staff member at all times.
13. All guests must sign a "release of liability".
14. No Red Fill Paintballs.
